MONTERRA HOA ARCHITECTURAL GUIDELINES

These guidelines are intended to help residents in the Monterra HOA know if actions they are taking with respect to their home and/or Lot require prior approval of the Architecture Committee. Refer to the Covenants, Section 5 for detailed information; specific sections are referenced in the relevant sections of the Guidelines, below.

Note that many changes to manufactured homes require the person making the changes obtain a work permit/inspection from the Washington State Department of Labor & Industries (L&I) prior to starting work. We have indicated in these guidelines the changes that require such permits. The Monterra HOA may ask you to provide evidence that the permit has been obtained before approved your Architecture Request. Details on what work requires a permit, obtaining a permit and the processes can be found at

In some situations, you may need to obtain a permit from Clallam County Building Division, such as when installing a new home, or installation of certain other structures on your Lot, depending on size/location of the structure. Consult the Clallam County Community Development Department to determine if your proposed change requires a permit.
