## **COVENANT & BYLAW REVIEW** COMMITTEE (CBRC) UPDATE

In its meeting on 22 February 2024, the MHA Board of Directors voted to accept a package of proposed covenant amendments as submitted by the CBRC in January and revised in February. This is now the final version of the proposals on which the membership will vote. The CBRC congratulates the Board on taking this significant step toward completing the long process of updating our covenants.

The CBRC amassed over 120 hours of work on these proposals. We met 16 times in the past two years. Two of our members participated in three Boardinitiated legal consultations to make our recommendations consistent with County, State, and Federal Codes and laws. As Chairperson, I reported CBRC activity at open Board and General meetings almost every time they were held. We spent many hours researching the revised Codes of Washington and other legal documents because our Covenants are out of compliance with current legislation in many ways. Each of us interacted with you, the homeowners, between meetings to get your input. We posted our meeting minutes in the clubhouse, and we also Page 2

kept you involved by summarizing our meeting outcomes in the Monterra newsletter. Finally, we formulated our proposals with the intention of doing the greatest good for the greatest number of residents because we wanted to present you with Amendments that are flexible enough to survive future changes in the law and adaptable enough to accommodate the ever-changing social and economic landscape.

The job of the CBRC is not finished. We must continue to collaborate with the Board to determine the best ways of helping you, the homeowners, understand the reasoning behind our proposed Covenant amendments, and we must develop the voting procedures and the ballots. Even then our work will not be done. After the Covenant revisions are approved, the CBRC will turn its attention to providing the Board with updated Bylaw proposals to make them consistent with the new Covenants.

All this work will be done in the upcoming Board and CBRC meetings, and as always, I urge you to attend each one. Monterra needs our collective wisdom and experience in these matters, and that makes it imperative that we be informed.

The scammer tells them they have a federal warrant and is using various law enforcement names to try to convince the citizen they are legit. This scam circulates every year and unfortunately, some citizens fall for this and are sending him money. He is telling the citizen they missed Federal jury duty and need to pay \$3,000.00 or go to jail.

### How can you conserve water this Spring and Summer?

**Indoors** Check faucets & pipes for leaks (including laundry and dishwasher hoses) Check your toilets. Older toilets can use up to 5 gallons of water every flush!

**Outdoors** Avoid overwatering. If runoff occurs, stop watering immediately. Avoid using a hose to clean your sidewalk, patio, or driveway, instead use a leaf blower or a broom.

# IMPORTANT NOTICE ABOUT POSSIBLE WATER RATES INCREASE

Cascadia Water, the company that provides water to Monterra, has filed a request with the Washington Utilities and Transportation Commission (WUTC) to increase the water rates they are charging us for the water supplied to our home, starting June 1, 2024. <u>The</u> proposed rate increase would be a 94% increase over our current rates (almost double).

There will be an open meeting of the WUTC on Thursday, May 23 at 9:30 am in Olympia. You may attend the meeting in person or remotely. If you want to participate remotely, call 360-664-1234 at least a day before the meeting to get sign-in instructions.
